Cohorts

Cohort 1:

In-person: Monday and Tuesday

Remote: Wednesday, Thursday, and Friday

Cohort 2:

Remote: Monday, Tuesday, Wednesday

In-person: Thursday and Friday

Transportation

- Students and bus drivers are required to mask and adhere to social distancing requirements at all times on the bus.
- One student per seat on the bus, unless immediate family members.
- All students will sit next to the window.
- Students who do not comply with distancing or mask wearing on the bus will be suspended from bus transportation. Parents will be responsible for student transport.
 1. First act of noncompliance: 1 week removal from the bus
 2. Second act of noncompliance: 2 weeks removal from the bus
 3. Third act of noncompliance: Removal from bus until CDC guidelines are lifted

Masks/Social Distancing

- All students and staff are required to wear a mask that covers their nose and mouth.
- Masks should be laundered after each day.
- Shields may only be worn with documentation of a medical necessity.
- Families are encouraged to provide their own masks, but the school will supply masks when necessary.
- Students who do not comply with distancing or mask wearing will be placed into fully remote learning.
 1. First act of noncompliance: 1 week removal from in-person learning
 2. Second act of noncompliance: 2 weeks removal from in-person learning

3. Third act of noncompliance: Removal from in-person learning until CDC guidelines are lifted

Arrival

- All students (likely with the aid of an adult) are required to self-screen each morning. Please use the screening questions that were sent home on 9/15. These questions can also be found on [medwayms.org](https://www.medwayms.org).
- 5/6th grade students should be dropped off at the front entrance of the building between **7:25 and 7:40 a.m.** and enter through the front door where their temperature will be taken.
- 7/8th grade students should be dropped off at the front entrance between **7:25 and 7:40 a.m.** and then proceed around the building using the sidewalk to the 7/8th grade door across from the music building. Their temperature will be taken at that door.
- All students will proceed directly to their homerooms. There will be no congregating and students stand 6 feet apart while waiting to have their temperature taken.

Dress

- Students should dress appropriately for the weather and temperature. We will be taking as many opportunities as possible to get students outside. This will allow students mask breaks. Students may also be eating outside when the weather is favorable.

School Supplies

- Students will be asked to bring their laptops, planners, pencil boxes, and class materials to and from school as they alternate between in-person and remote learning.
- Students are strongly encouraged to bring a refillable water bottle each day.

Instruction Options

- Families who do not feel comfortable with the hybrid plan may opt for their child(ren) to remain completely remote.
- MMS needs to be notified by 9/23 of your intent to remain remote.
- Families can reevaluate their decision to remain fully remote at progress reports (Oct. 16, Jan. 22, and April 16) and trimester end (Nov. 24 and March 5).
